# RESOLUTION OF THE BOARD OF TRUSTEES OF THE UTAH TRANSIT AUTHORITY APPROVING REQUEST TO THE UTAH DEPARTMENT OF TRANSPORTATION FOR USE OF EMINENT DOMAIN FOR ACQUISITION OF PROPERTIES FOR THE PROVO OREM TRANSPORTATION IMPROVEMENT PROJECT

No. R2017-06-01 June 2, 2017

WHEREAS, the Utah Transit Authority (the "Authority") is a public transit district organized under the laws of the State of Utah and was created to transact and exercise all of the powers provided for in the Utah Limited Purpose Local Government Entities-Local Districts Act and the Utah Public Transit District Act; and

WHEREAS, the Board of Trustees (the "Board") has approved the project known as the Provo-Orem Bus Rapid Transit Project, to design, construct and operate a Bus Rapid Transit as part of the joint project with the Utah Department of Transportation known as the Provo Orem Transportation Improvement Project; and

WHEREAS, as part of the Provo Orem Transportation Improvement Project, and to complete construction of the Provo Orem Transportation Improvement Project, certain right-of-way acquisitions have been identified; and

WHEREAS, Authority staff and consultants have made diligent and reasonable efforts to acquire the right-of-way necessary for the Provo Orem Transportation Improvement Project, but have been unable to negotiate certain of those acquisitions to completion; and

WHEREAS, in order to complete the Provo Orem Transportation Improvement Project, and to meet budget and schedule needs, certain right-of-way acquisitions need to move forward through the eminent domain process; and

WHEREAS, Board Executive Limitations Policy No. 2.2.2 requires that, prior to acquiring property through eminent domain, the Board must be allowed to review and make a decision on such action.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Utah Transit Authority:

1. That the Board hereby authorizes the President/CEO and Authority staff to request that the Utah Department of Transportation commence eminent domain proceedings on the properties presented to the Board, each identified by its respective Provo Orem Transportation Improvement Project parcel number on Exhibit A attached hereto.

- That the Board further ratifies the Board's action to request that the Utah Department of Transportation commence eminent domain proceedings on certain other properties, identified by Provo-Orem Transportation Improvement Project parcel number on Exhibit B, that were presented to the Board on April 12, 2017.
- 3. That this Resolution stay in full force and effect until amended or rescinded by further action of the Board.
- 4. That the corporate seal be attached hereto.
